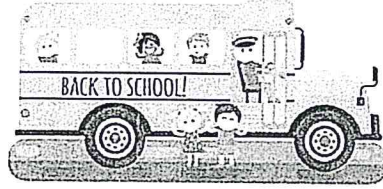

Dear CLPS Families,

Welcome to the 2019-2020 school year. We are very excited to be transporting your children this year. With that being said, we do have a few changes that we want to make you aware of.

Within the village limits, instead of stopping at individual houses, we are going to create TWO bus stops. There are a few reasons for this, including less time on the bus for the kids, legal guidelines, and cost savings. Enclosed is a map highlighting the two bus stops. If you do not live in those boundaries, your student will be picked up like they were last year.

Stop Number 1 - Howard and Ballard - the students who live within those boundaries will need to use that bus stop. *We will not be going house to house.* (map enclosed)

Stop Number 2 - Central Lake Library - the students who live within those boundaries will need to use that bus stop. *We will not be going house to house.* (map enclosed)

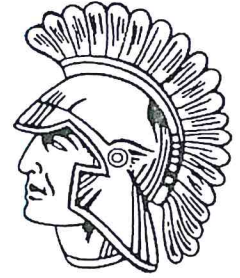
